Call to Order, Establishment of Quorum, Approval of Minutes, and Introduction of New Members	Jesse Gibson, Committee Chair, called the meeting of the Georgia Committee for Trauma Excellence (GCTE), a committee of the Georgia Trauma Commission (GTC), to order at 2:00 pm. A quorum was established, with seven of eight members present. Jesse welcomed everyone and asked any new members to introduce themselves. After introductions, Jesse Gibson asked for a motion to approve the meeting minutes from November and February.

MOTION: Tracy Johns SECOND: Kellie Rowker DISCUSSION: None ACTION: The motion PASSED with no objections nor abstentions. MOTION GCTE 2022-05-02: Motion to approve the meeting minutes from the February 28, 2022, meeting. MOTION: John Pope SECOND: Tracy Johns
	DISCUSSION: None ACTION: The motion PASSED with no objections nor abstentions.
Georgia Trauma Commission (GTC) Update	Liz Atkins gave an overview of the recent updates from the Georgia Trauma Commission.

	 Level III/IV Trauma Center Readiness Costs Survey: The work resulting from this was accepted for the main podium presentation at the American Association for the Surgery of Trauma. This reflects the desire for costs associated with rural level III/level IV trauma centers. We're closely monitoring Super Speeder revenue, and Dr. Dunne asks if we can do any education to state patrol or police about where the money goes. We can probably utilize the trauma centers for outreach. Tracy Johns asked if an infographic could be created. Liz Atkins stated that it could be done. The Commission approved the ACS Rural-Focused Consult Visit dates, January 9-13, 2023. We are currently working through logistics. AFY2022 and FY2023 budgets and web-hosting for Levels III/IV were approved.
Office of EMS & Trauma	Marie Probst reported on behalf of the Office of EMS & Trauma:
Update	 Renee Morgan has been working on multiple Level III/IV visits. She is working closely with ACS for the Level I and II dates. OTCPE and OVCPE quarter three reports are all closed except for two. We are waiting for Trauma Medical Directors to sign the missing two. Quarter three completes the 2021 dataset. The record closure rate for 33 centers is 82.4. The overall response rate for Levels I and II is 85 statewide over the 25 centers. We have a DPH website, dph.georgia.gov/trauma. We have the 2022 Georgia Data Dictionary, which we have updated with the 2023 download and reporting schedule. We will also send it out by email. We will begin preparing the 2023 fiscal quarterly report in the license management system. We'll use the new 2022 ACS standards and follow the Georgia Trauma Commission's items for Performance-Based measures. The OEMST has met one of the GCTE goals of increasing trauma awareness by publishing the 2019 Trauma Registry Annual Report. Danlin prepared the document, and DPH has approved it for release. It is primarily a demographic analysis from the epidemiologist's perspective and mirrors the old NTDB report we used to get. Danlin is working on the 2020 report to roll out as well. The ImageTrend Patient Registry Central Site is still in the pilot phase. CHOA is our primary pilot center right now, and we are trying to perfect the files. The ball is currently in ESO's court, so we're waiting on the updated files to retest the import. Once the pilot phase is completed, the files can go out to all v5 users. Then we can start resuming the downloads by the end of June or the beginning of July for our data

	analysis. Once the pilot phase is completed, we will re-do the training and record it for users. It took about 15 minutes to set up with the pilot center.
Georgia Trauma Foundation Update	Cheryle Ward provided an update on behalf of the Foundation. We have historically been involved with education, and we are currently working on a project with the State Office of Rural Health to spearhead a continuing education database. It will serve as a one-stop-shop to identify course faculty for the state and nationally approved programs. We expect to have it go live by the end of this year. We continue to focus on our philanthropic efforts in fundraising. We have partnered with a fundraising consult company, Alexander Haas, to help put resources in place to help raise funds to support the trauma system.
Georgia Quality	Gina Solomon provided a brief review of GQIP's latest activities:
Improvement Update	 Arbormetrix: The new contract process requires contracts involving software to be reviewed by the Georgia Technology Authority (GTA). Their review requested numerous changes. Changes completed & back to commercial contract team to finalize and resend to GTA for approval. Once GTA approves can send to benchmarking platform vendor. The trauma centers would say on v5 at least for the next three years to make the Arbormetrics process easier. Workgroup Updates AKI: Plan for more recent data pull for comparison to 2017 data. Poster submitted by Dr. Jesse Codner on AKI Physician Practice Survey accepted at Quality & Safety Conference. Dr. Codner will be leaving us in June to start his clinical. We will have a research resident from Emory take over that role. TBI: Completing larger data pull from centers for analysis. Opioids: Continuing to work on Multimodal guidelines. Meetings continue with the special counsel and AG office. The recent focus is on clarifying the status of HIPAA-covered entities. Moving forward, GTC is clarified as a noncovered entity regarding HIPAA.
Subcommittee Reports	Education: Jesse Gibson reported on behalf of Jessica Mantooth:
	 Transfer to Definitive Care: A workgroup has been created within the Education Subcommittee to focus on this initiative. A literature review has been done, and objectives for the education material have been created. An outline has been shared with the group. Discussion regarding whether it is valuable to determine which injuries require a rapid (2-hour window of transfer) versus those that do not. Acute Kidney Injury: Objectives and literature reviews are the first steps in creating educational material.

	3. Utilizing State Funding for Education: The state had education funding left over from the previous FY. They have asked the education subcommittee to help fund educational offerings. The Education Subcommittee had approx. \$11,000 to help fund educational offerings around the state.
	 Funding an ATCN course at Grady on June 11 for \$4000. Twenty-four applicants for the course at Grady. 16 participant spots. We will accept all non-trauma applicants or hospitals that only have one applicant. We will try to accept two applicants from the other trauma programs who applied. Erin and Jessica will work together
	 to prioritize the names for the other spots. Funding TNCC Provider Course at Phoebe Putney \$5000 – invoice has been sent to the state. TNCC Instructor Course at Piedmont Henry \$1,000 – invoice pending being sent to the state. Purchased the new STN Trauma E-Library for the state-wide trauma designated or ACS verified trauma center use. Jessica is working on the Agreement letter for hospitals. We will share the E-Library to the Education Committee Teams folder for dissemination.
	Pediatric: Kelli Rowker updated the committee:
	 Pediatric Readiness Presentation: There will be a presentation on pediatric readiness during the summer Day of Trauma meeting. The session will specifically target adult trauma centers to help prepare for the requirements of the Gray Book.
	Pediatric Readiness Package: The subcommittee is putting together a pediatric readiness package to be distributed at the summer meeting.
	3. Gun Violence: Collaboration with the Augusta team on a violence intervention program targeting pediatric gun violence. There is potential for a presentation on this during a future meeting.
	4. SIPA: Working with Education Subcommittee and the Registry Subcommittee to move the project forward.

	Performance Improvement: John Pope updated the committee. We have met twice since the Barnsley meeting and have decent membership. We have asked for a deidentified chart pull that will allow us to narrow down on definitive is due May 25 th . Level I and II will send transfer ins, and Level III and IV will send transfer outs. Once we dial in the data points, we will work with the registry committee to figure out the missing data points and assist in capturing the data. The date range of the report is July to December 2021.
	AKI is tabled due to other groups working on the goal. We are still meeting every second Wednesday morning. If you are interested in joining, please reach out to John.Pope@piedmont.org .
	Liz added that she sent an email to the group regarding the Level IV customized report and recommended putting it on the agenda for the next meeting. In October, level IV will also need to run their PRQ for their consult visits. Kelli asked when the web-based hosting would take place. Liz explained that the quotes would be sent to the centers, and each will need to complete a security assessment. Liz asks the PI and registry group to consider what would be meaningful for a Level IV report. Tracy Johns mentioned that John, Kelli, and Lynn Grant could get together to list the types of reports they need. PTSF has not sent out the PRQ yet, but Liz can send that over to them to look over. After the report is built, we can send screenshots to ESO for the build.
	There was a lengthy discussion regarding updating AIS 2015 and the TQIP survey regarding its usage. Per Marie, ESO has the capability of AIS 2015 and she has requested a quote to see how much it would cost to convert to it. Jesse suggested discussing the AIS during the registry subcommittee meeting to hash out the details.
	Registry: Kelli Vaughn updated the committee.
	Time to Definitive Care: Continue working on a report to distribute to centers to run and identify themes in the reports
	 2023 Registry Requests: Requests for changes to the V5 software presented for approval of the sub- committee

	 3. 2022 ACS Standards Presentation: Discussion around data inclusion criteria, acceptance of state/local inclusion criteria, and 0.5 FTE per 200 – 300 registry patients Educational requirements
	 Survey monkey was distributed to all centers related to the above standards for feedback on education needs/ requests
	Injury Prevention: Jesse Gibson provided an update on behalf of Kristal Smith:
	 Increase Trauma Awareness: Each of the IP and Outreach Subcommittee Task Forces (Special Events, Falls, Traffic Injury, and Intentional Injury) will produce at least ONE webinar in 2022.
	2. Georgia STOP THE BLEED Training Blitz: The Special Events Task Force assisted with the STOP THE BLEED® - Bleeding Control U event for colleges and universities. There were more than 200 participants. The Georgia STOP THE BLEED® Blitz is underway with a full day of STOP THE BLEED® Webinars planned for May 19, 2022. Trauma centers and trauma system partners are encouraged to provide a STOP THE BLEED® training offering during May (National STOP THE BLEED® Month). Training can be directed to staff members and the community. With the popularity of on-demand and webinar offerings, In-person Skills Only courses are needed. Over 2,000 participants in Georgia Trauma System STOP THE BLEED® Webinars to date.
	3. Prevent Trauma-The Road Ahead: The Traffic Injury Prevention Task Force hosted, Prevent Trauma, The Road Ahead, a peer-led teen driving webinar on Thursday, March 24, 2022, at 7:00pm. The panel discussion featured two moderators from Northeast Georgia Medical Center, a Georgia Trauma Survivor, Teens for Balwin County High School's Teens in the Driver's Seat (TDS) Team, and deputies from Monroe County Sheriff's Office. There were over 70 attendees from fifteen Georgia counties. (49% Teens, 40% Parents, 11% Teachers or Community Partners).
	4. Prevent Trauma- Child Abuse Prevention: The Violence and Self-harm Prevention Task Force hosted Prevent Trauma: Child Abuse Prevalence, Prevention, and Response on Wednesday, April 27th, at noon. Our Georgia Trauma System Partners from Memorial Health University, Atrium Health Navicent, August University, and Children's Healthcare of Atlanta participated in the panel discussion. There were over 25 attendees from ten Georgia counties.

	5. Bingocize and Falls Free Fridays: We completed a multi-site Bingocize cohort on March 31, 2022. Facilitators included the Middle Georgia Regional Commission (MGRC), Atrium Health Navicent, Fairview Park, Northside Gwinnett, Kennestone, and Grady. There were over 125 participants from ten counties. Northeast Georgia and Memorial Health University also facilitated cohorts this past quarter. We partnered with the MGRC to provide a Bingocize webinar to the Georgia Department of Human Services, Division of Aging Services on April 12, 2022. The next multi-site Bingocize cohort, coordinated by Northside Gwinnett, is set for June.
GCTE Goals/Vision	Jesse Gibson reminded everyone of the GCTE goals as a 2–4-year strategy to align our work with others across the state. We came up with three major initiatives for our state that then the subcommittees could develop goals around and impact: 1. Time to Definitive Care 2. Increase Public Awareness of Trauma 3. AKI Quality Improvement Based on the subcommittee reports, I am proud of what we're doing and how all the groups are tapping into that by trying to address at least one of those issues. Tracy Johns added that we had challenged everyone to do SMART goals so they can be clear and measurable. We can follow up with the subcommittees that have not turned theirs in. Tracy mentioned adding all the GCTE subcommittee meetings to the website and having the contact information available for anyone that wants to join.
Survey Results and Next Meetings	We sent out a survey asking for feedback on meeting schedules. Historically, we have had the GCTE meeting with the Commission Meeting. The logistics have become more complex, and it seems the best scenario is to have the meetings be on separate days. We can have our meeting before or after the Commission meeting. The next meeting will be in August, and we can tentatively look at August 25 th as 100% virtual. Liz recommended having the November 16 th meeting hybrid option, which could be at the Marriott in Macon, GPSTC in Forsyth, or Navicent. The time agreed upon would be 10 AM-12 Noon.
New Business	 Gina Solomon stated we have a big group of APPs working with our trauma groups and Emergency General Surgery We thought about creating a survey to make it a more cohesive group. If you think of anyone interested in joining, please send their contact to gina@gtcnc.org.
