Georgia Trauma Commission	Katie Hamilton gave a couple of updates on behalf of Liz Atkins:
(GTC) Update	 Reviewed FY2022 Performance Based Pay (PBP) Results (ATTACHMENT A): If the center did not meet the criteria, funds were forfeited and redistributed to centers that met the criteria. Reviewed FY 2023 PBP Criteria (ATTACHMENT B): No changes from previous fiscal year criteria. Before FY2023, you would receive your funds in two stages: base and amended. Now, with the establishment of
	the Georgia Trust Fund, we receive our full Super Speeder funds upfront. Due to the increased allocations, there is an increase in risk dollars. Your FY2023 score will affect your FY2024 payout.
	 GCTE feedback is requested for FY2024 PBP Criteria, which will determine FY2025 funds. Take into consideration meeting attendance and attendee requirements. One suggestion was the TQIP attendance requirement for PI Coordinators and Registrars.
Office of EMS & Trauma	Marie Probst reported on behalf of the Office of EMS & Trauma:
Update	 Michael Johnson is the new Office and EMS and Trauma Director.
	We had our Trauma Center Orientation call yesterday with 18-20 attendees within the two sessions.
	 The ImageTrend Patient Registry Central Site is still in the pilot phase. Following up with the pilot centers to start training.
	 OTCPE and OBCPE forms for FY 2022 have been reviewed. The FY 2023 form will be revised. If you have any recommendations for changes, please let me know. Those reports are designed to help each center track the deliverables of contracts between OEMST and the Georgia Trauma Commission. FY 2023, Q1 report will be due October 15th, 2022.
	 Danlin's 2020 Annual Report has been completed and sent for approval. It is set to be released at the November Commission meeting. The 2021 report is pending data, tentative August 2023 release.

Update	 We have created a Continuing Education Database for the trauma community to identify trauma educator providers across the state It is a free, password-protected resource, and we require your permission to publish your information. Georgia Quality	Gina Solomon provided a brief review of GQIP's latest activities (ATTACHMENT D):
Improvement Update	 Arbormetrix: Project launch should be around quarter 1 or 2 of 2023. You may get an email from me asking you to participate in the build process. Hope to get representation from PI coordinators, Registrars, and Program Managers to provide feedback.
	 We asked Day of Trauma attendees what process measures we should focus on (slides 4-5). The top 3 results were: VTE Prophylaxis, PRBC to FPP ratios in MTP, and Non-surgical admit rates. The top 3 outcome measures were: Mortality, Unplanned Admission to ICU, and AKI. The results give us an idea of what to focus on regarding our project data points and dashboards.
	 ESO Central Site project kicked off July 1st and is looking to accept data starting at the end of
	September/beginning of October. The validation rules will be the same as your state downloads.
	 All Trauma Program Managers received an email from me Monday asking for two users from each center; name and email address that will have the logins for the central site. There will no longer be a generic login for centers due to security reasons. We will be able to add and remove users as needed. Dr. Eli Mlaver is our new GQIP Research Fellow.
	 Day of Trauma presentation PowerPoints will be posted on the trauma.ga.gov website under the event date.
	 We are starting the Winter Meeting planning to be set at Chateau Elan. The dates are February 27th-March 1st.
	 Please note on your GTC contracts; that designated centers must submit data to the GQIP central site to receive funding. The other item is to maintain the ESO registry.
Subcommittee Reports	Education: Jesse Gibson reported on behalf of Jessica Mantooth:
	 Continue to meet monthly, every first Tuesday of every month from 11 am to 12 noon.
	 Transfer to Definitive Care and AKI PowerPoints: The literature review has been completed, and objectives for the education material have been created. An outline has been shared with the GCTE chairs for
	feedback. PowerPoints are meant to be a resource to be sent out to both trauma centers and non-trauma centers. Our goal was to complete this by the end of June, but we are now targeting the end of the year. If
	you have any feedback or recommendations, please send them to me or Kyndra Holm.
	 Utilizing State Funding for Education: The state had education funding left over from the previous FY. They have asked the education subcommittee to help fund educational offerings. The Education Subcommittee had approx. \$11,000 to help fund educational offerings around the state.

	 Funding an ATCN course at Grady on June 11 for \$4000. Sixteen participants were set to attend but had last-minute cancellations due to COVID. Erin is going to work on getting those people into other courses. Funding TNCC Provider Course at Phoebe Putney \$5000 – completed June 30th and July 1st with 19 participants. TNCC Instructor Course \$1,000 – to be confirmed. Purchased the new STN Trauma E-Library for the state-wide trauma designated or ACS verified trauma center use. 	 Pediatric: Kelli Rowker updated the committee: We had a meeting last week. Continuing to work on Pediatric Readiness and have come up with a solid list of equipment to care for pediatric trauma patients. Pulled some pediatric trauma-specific guidelines, and Kyndra has kindly volunteered to skinny them down for more clarity on what pediatric patients need to be transferred in a timely manner. Hope to connect with Injury Prevention to see if they have anything to add to the Pediatric Readiness Toolkits Shared SIPA data between CHOA and CHOG to analyze. CHOA has decided to utilize trauma video review to study the SIPA score, specifically the recognition of shock and time to blood products.
	 Registry: Kelli Vaughn updated the committee. Registrars met on July 28th to review the time to definitive care reports Created a template to send out screenshots and different people run those reports. We are getting that information back to Gina to look at patterns or themes. For the first time, we did a case study presentation and facilitated polling questions for interactive participation. Debbie Bowman from ESO discussed the web-based registry and the next steps.
