

#### **Proposed Actions to be Taken**

- 1. MG90 phase-out begins next quarter.
- 2. Bulk Purchase Some MG90s now for replacements with Bluetooth or Asset Manager requirements in the next year or two
- 3. Change the Distributor and Tech Support from ITS to PSS-MO as soon as possible. The manufacturer remains SemTech.
- 4. Begin reimbursing small rural agencies that need help to get Gateways installed
