CALL TO ORDER

The meeting was called to order at 8:30 a.m., with 35 in attendance. Kelli Vaughn welcomed everyone and started the meeting by approving the meeting minutes.

GTC Update

Presented by Liz Atkins

Legislative session updates:

- Entering the legislative session, there are no major changes for the commission this year.
- Updates planned for Senate Health and Human Services and House Public Health Committees.
- Appropriations for FY26: no surprises expected due to predictable trust fund management.

Inter-rater reliability (IRR) program:

- Contracts with Q Centrix are progressing; implementation is delayed but moving forward.
- GTC funding implementation fees; scope of work finalized, pending sole source approval.
- Amendments clarified: First Amendment: one-year term for IRR funding with auto-renewal to maintain system access if continued. Second Amendment: funding for clinical data validation and re-abstraction services was added to contracts.
- IRR implementation starts once all contracts are executed; the goal is January start, pending contract finalizations.

Consultative visits for level 4 centers:

- Pennsylvania Trauma System Foundation to offer performance improvement consultations in June.
- Visits to address prior findings and provide feedback on progress.
- Commission-approved funding placeholder; centers must confirm participation.

IRR clarifications:

- Program limited to data validation, abstraction accuracy, and performance improvement.
- Q Centrix provides detailed accuracy feedback for timeliness, coding, and abstraction errors.
- Data is exported in Excel for analysis; there is potential for targeted education and aggregate reporting.

Opportunities for aggregate data sharing:

- Potential to align level 4 findings with level 1-3 processes for shared education and benchmarking.
- Goal: improve data quality for meaningful comparisons and build tailored level 4 education programs.
- GTC and ArborMetrix are working to integrate level 4 data into broader reporting frameworks.

MARCH PAWS UPDATE

Trauma Connections Group Update

Presented by Rachel Hand

- Monthly calls continue on the 3rd Wednesday.
- Discussed Trauma Flowsheets, validation reports, TQIP data submissions
- Some centers found including all activations (vs. just inclusion criteria cases) skewed TQIP results. Registry subcommittee to inquire with higher-level centers on registry data entry practices and TQIP discrepancies
- Requesting clarification on Q Centrix role: IRR only vs IRR + data entry + data submissions.

NEW BUSINESS | PERFORMANCE BASED PAY

Presented by Gabby Saye

- PBP Workgroup Overview (**ATTACHMENT A**): Gabby outlined updates from the PBP workgroup, including edits to criteria, changes to percentages, reformat, and new measures added for FY2026. The group includes eight stakeholders, including Kelly and Rachel.

- FY2026 Additions: Two new outcome measures will be added for Level 3 trauma centers: timely VTE prophylaxis and timely surgical repair for geriatric hip fractures. Level 4 centers are excluded. Gina highlighted these measures align with MTQIP and TQIP reports, with efforts underway to implement metrics in the next 3-4 months.
- VTE Prophylaxis Workgroup: A statewide guideline is in progress, along with data analysis by the GQIP scholar to assess current compliance. The group aims to assist centers struggling with implementation while maintaining low initial thresholds to account for exclusions.
- Level 4 Criteria Update: Trauma registry professionals must demonstrate completion of specific courses (AIS 2015, Trauma Registry, or ICD-10) or eight hours of continuing education.
- Participation Tiers: Meeting attendance criteria now have tiered percentages for senior executives and key trauma program personnel. This replaces the all-or-nothing scoring system to minimize penalization for partial attendance.
- Scorecard Timing: Discussions are ongoing about transitioning PBP scorecards from the calendar year to the fiscal year and potentially deferring submission to August.
- Upcoming Steps: A finalized PBP draft will undergo an open comment period before committee review. The PBP workgroup will meet again on February 5 to finalize the criteria for Level 1 and 2 trauma centers and address the scorecard cadence.

Trauma Awareness Day Update from Cheryl Ward with the Georgia Trauma Foundation

- Being rescheduled from Jan 28 due to conflict with State of Judiciary
- The new date is TBD, likely in the first half of the legislative session
- Will recognize 4 state lawmakers for supporting trauma care
