Welcome and Introductions

Mr. Hinson welcomed all present at the meeting. Mr. Hinson recognized a quorum of the voting members were present.

Approval of Minutes from November 2 Meeting

The first order of business was the approval of the minutes from the 2 November 2010 subcommittee meeting.

AVLS PROGRAM UPDATE

Mr. Jim Pettyjohn presented an update on the AVLS Program. Mr. Pettyjohn reported that they are working with GTRI to close out their contract at the end of this month. There will be approximately \$13,000.00 left over and this money will be used for airtime and purchasing new units that will be distributed after the first of the year. Mr. Kirk Pennywitt suggests that the opportunity exists to use \$4,800.00 of this money to go ahead and provide the five log-ins for the participating agencies now. He feels that would be great use of the money and it would set a precedent when we move forward with GEMA. Mr. Pettyjohn is bringing this to the committee for a recommendation.

Mr. Ben Hinson reminded everyone that now each agency has two log-ins and InMotion stated they would make five available per provider for \$180 per agency and there are 27 agencies.

Mr. Ralph McDaniel questioned if we use this money today, how will that affect the remaining services that have not started up with the program at this time and would there be money to pay for their log-ins? Mr. Ben Hinson replied that it will not affect anyone that has not gotten the system that is set to get it under this year's contract.

Mr. Jim Pettyjohn stated that everyone who submitted their order will get their units. We are working with Dodge County, Peach County, and Augusta Fire Department to get their signed MOA. Nobody will have to wait on their units if we use this money for the additional log-ins.

MOTION #2 EMS Subcommittee 2010-12-07:

I make the motion to use \$4,800.00 of the excess funds that cannot be encumbered otherwise to purchase the five log-in seats for each participating provider right now.

Discussion

Mr. Lee Oliver suggested that as we move forward with GEMA that this can be included in the package.

Mr. Ben Hinson stated that this is the biggest application that has been put together by In-Motion and this will definitely put them in the driver's seat and with them helping us, this will be a win for everybody. Mr. Ben Hinson stated that this will be in the form as a recommendation to the Trauma Commission.

Mr. Jim Pettyjohn reported that on November 22, 2010, there was a AVLS Working Group Meeting held at the Georgia Tech Global Learning Center that was hosted by GEMA and the staff of the GTRI folks. The meeting was to begin the process of "handing off" or the collaboration between the first year of phase one of the AVLS program with the out years, phase two and phase three, using DHS federal funds through GEMA to the State of Georgia to provide these AVLS units state-wide to EMS providers. Members from this EMS Sub-committee that were in attendance were Mr. Huey Atkins, Mr. Lee Oliver, and Mr. Courtney Terwilliger. (***The meeting minutes are attached***) The follow-up meeting will be held Thursday, December 16, 2010 beginning at 1:00 p.m. and concluding on Friday, December 17, 2010, at 12:00 noon.

Mr. Ben Hinson thanked those for attending.

Mr. Courtney Terwilliger stated that GEMA is interested in meeting the needs of the EMS community. He feels there is great potential for job training as we role this out.

Mr. Ben Hinson stated that GEMA does a great job of training and that FEMA has finally understood that if you have a system for disasters and only use it for disasters that it will not work. You have to use it on a daily basis.

Mr. Lee Oliver reported that we are going on a Verizon predominant network and we are treated as any other Verizon customer. We have challenged GTRI to talk with the providers to see if we could be given priority in case the systems are compromised or limited in their capacity. If the system does go into a fail mode, then we would have an elevated status.

Mr. Jim Pettyjohn stated that there would be more to report at the next committee meeting.

UPDATE FY 2010 EMS FUNDING PROGRAMS UPDATE

FY 2010 EMS Vehicle Equipment Replacement Grants

Mr. Jim Pettyjohn reported that all 29 have received their award letters which was really the threshold that was put in place before we move forward. The Commission has had some problems with DCH in having things documented and in place. Everyone has a signed agreement letter and we are in the process of working with them to make sure they have a work-plan. Seven have been approved with six having submitted their invoices which in turn have been submitted to DCH for payment. We are moving along and working hard to get everybody their money. Next year will be different.

Mr. Ben Hinson asked Mr. Pettyjohn to comment on the change of Commissioner. Mr. Pettyjohn responded that he had just heard this information today. He stated that he had heard that the Commissioner was moving to DHS but not sure who is going to be at DCH. The name of David Cook has been heard to replace him but this is not for fact.

First Responder Training Grants and Trauma Care Related Equipment Distribution

Mr. Courtney Terwilliger provided hand-outs which are attached to these minutes. Mr. Courtney Terwilliger stated that in the hand-out is a copy of the letter that was sent out for services that received the equipment grant. We recognized up front that some had applied for the number of staffed ambulances but this grant was for each ambulance the service had. This was corrected with each service. There is also an Affidavit that was completed and signed by the EMS Director.

Mr. Ben Hinson stated that he felt that in the future we need to include on the Affidavit that the services are also saying they will keep the invoices for five years for auditing purposes.

Mr. Courtney Terwilliger reported that checks should begin going out on Monday for reimbursement as long as they have meet the criteria.

The following pages in the hand-out are the services and the amount of award money that will be issued. We have a total of \$321,651.00 to spend which rounded off to be \$361.00 per ambulance.

Mr. Courtney Terwilliger reported that he had a request from Michael Coleman with Grady for a variance to use \$800.00 to purchase a commercial washing machine. Mr. Coleman is interested in having a machine that can clean his straps and equipment that is washable and be placed back on the truck without infection control being an issue. Mr. Terwilliger feels that we need to support this.

I make the motion to recommend to the Trauma Commission that they approve the request for the variance from Grady EMS and allow them to use \$800.00 to purchase a commercial washing machine.

Mr. Courtney Terwilliger stated that, as of now, he has had two request for variances. We have also had a request for a thorocotomy needle for chest decompression.

Mr. Richard Lee feels that these variances are something we can add to the list if we feel it is a good idea.

Mr. Courtney Terwilliger stated that as we move along, we live and learn, and if these are approved by the commission as a variance, we add these to our list of approved items.

Discussion

Mr. Huey Atkins commented, in the future, since this money is supposed to enhance our trauma care, we make sure whatever the request is, that the services are doing the basics. He feels if a service requests a washing machine that we need to make sure they have enhanced trauma related items that would enhance patient care also.

Mr. Jim Pettyjohn stated the Commission stated that the money was provided to purchase trauma care related equipment above the list required by the Office of EMS.

The motion **PASSED** with no objections, nor abstentions.

Mr. Courtney Terwilliger reported on the First Responder Grants that emails have been sent out to the first 52 recipients. A copy of this letter is attached with a list of the services that had applied and the scoring process that was used.

The scoring shows that the high scores got the grants first. Grants on the second round should be released in January, 2011. We wanted to make sure we had the money to do it. We have not gotten all the bids for the first responder bags and are waiting on other vendors to receive their bids. 1200 jump bags will be purchased first. We feel that we will be able to go into the third round. We have allowed as few as 12 and as many 25 in the class and we will not pay more for additional students over the 25. Second round will be notified in January and it will be their responsibility to get with region program manager to get approved course set up. As soon as we have the listing and the verification from the program manager along with their roster, we will send them a check for one-half of the fee. At the end of course, they will provide the program manager with end of course roster, and after approval jump bags will be sent to the services. We are also looking at OSHA approved vest as the money become available.

Mr. David Moore stated that this was a great job done on this.

UNCOMPENSATED CARE:

Mr. Ben Hinson stated that Uncompensated Care needed to be looked at. Handouts were given with a listing of each county in the state with population then divided by the square miles to get the density. The density rating was used simply because the Trauma Commission used this on the vehicle scoring. This is the 2000 census so this will change. If you recall, after Huey's group worked on this we agreed to pay the Medicare rate for the state and we will pay the regular mileage rate but if you are in a rural area, you will receive the 50% increase on mileage. Everybody will be paid the same regardless of what they bill. The Medicare rate will be a placeholder to use in the calculation based on the amount of money we receive and the amount of money that is requested. Medicare pays all claims based on the zip code of where you picked the patient up. There was discussion at our last meeting to simply designate which counties qualify as rural by the Trauma Commission and you will put on your claim form what county you are in and whether or not you are rural, then that will be used as the basis for your payment calculation. The Trauma Commission has asked us to give them a suggestion on what was rural and what was not. We can rank it purely by population or by density. Mr. Hinson suggests that we determine where the line is drawn based on population density and then you list where your county is based. This is the simplest way to do it.

Mr. Huey Atkins also agrees that it should be based on density. Is there a template that we can apply to see how it would impact? Can we apply this to last year's payments and see how it would look?

Mr. Ben Hinson states that the amount of money paid for Uncompensated Care will be fixed by the Trauma Commission. Where this line is drawn will simply decide how much the different services will get. We need to be very careful when we draw this line that we don't do a great deal of calculation in any one side or the other.

Mr. Courtney Terwilliger states he feels that we need to make it as equitable as we can. This needs to be equitable for both rural and urban services. He also questioned, "Where did the population totals come from?"

Mr. Jim Pettyjohn responded that the last time the sub-committee approved to use the estimated 2009 data to determine the density.

Mr. Ben Hinson stated there is no solid logical way to do this and that we need to draw a line and get Jim to redo this sheet with the latest population numbers. There is no time press on this since we won't be working on this till February or March.

FY 2011 EMS FUNDING

EMS Vehicle Equipment Replacement Program

Mr. Jim Pettyjohn stated that there had been some conversation about redistributing some of the commission's money to EMS to buy more AVLS units. Mr. Pettyjohn wants to revisit and clarify a couple of points, one being that we are settled with the money distribution to move forward and two, Mr. Pettyjohn needs a partner to work with as we move forward on this EMS Vehicle Replacement Grant and they will need to visit with him as we go to DCH to start going through Grants administration as we get started.

Mr. Ben Hinson stated he would take this into advisement and will be appointing someone.

Mr. Huey Atkins stated that he wanted to clarify the email that was sent out. After their meeting with GEMA, he feels that it is not necessary to consider this now.

Minutes approved on 08 February 2010

Mr. Pettyjohn replies that the person who is identified cannot be a person who is applying for a grant and Mr. Pettyjohn feels that it would be helpful if the person was from the Atlanta area due to the travel involved.

Mr. Ben Hinson again states that he will be appointing this person from the sub-committee and that person cannot be applying for a grant.

First Responder Training Criteria and Trauma Care Related Equipment Distribution Criteria

Mr. Courtney Terwilliger reported that we want to continue doing what are presently doing. He stated that he can see a few years down the road that First Responder training might not be needed but at this time we want to continue as we have been. He has had a request for funding for an EMT-B course. He stated that the cost of the EMT-B is three times that of the First Responder Course.

Mr. Courtney Terwilliger also would like to see the Trauma Care Related Equipment to stay the same. He feels there are services out there that would still request funding.

Mr. Huey Atkins states that a lot of these rural counties are hurting for personnel and the EMT-B would help these services in that area. He feels that this would be a good program to get started in. To go from a First Responder to an EMT-B is not but two or three more classes.

Mr. Courtney Terwilliger would like to go a least one more round with the First Responder. He suggests that at the next meeting that we have a presentation on the differences and costs between the First Responder and EMT-B classes. We need to look at these classes closely and use as a learning opportunity as to how we can further these classes.

Mr. Ben Hinson reported that we are in the budget with the same percentage and when the Commission sees where the dollars go, we have a good chance in raising it.
