Injury Prevention

The IP Subcommittee has been busy since the last GCTE meeting. We have worked hard to strengthen our partnerships and collaborative efforts with DPH, IPRCE, etc. Additionally, we are focus on strengthening our collective efforts by sharing successes and partnering in multi-center prevention initiatives.

Our three IP Task Force groups met on September 4th and again on November 6th we had our larger IP Subcommittee Meeting on October 2nd.

- The Traffic Injury Task Force meetings have featured special reports on ongoing state-wide prevention efforts with a focus on how designated centers might promote and or support partner initiatives. In September Ken Bain from (Life Changing Experiences Community Education Project) presented information about two programs from the Governor's Office of Highway Traffic Safety. Cinema Drive and Smart Driver. The program is funded through GOHTS for 100 schools through 2021. Cinima Drive can cover 200 students per screening but can also do multiple screenings in a day.
- The Falls Prevention Task Force discussion focused on Falls Prevention Awareness Month/Day and the utilization of the Falls Prevention Social Media. The Social Media Guide was designed to help trauma centers and partners utilize social media platforms to support and promote fall prevention in older adults.
- The Violence Prevention Task Force discussed the ASK (Asking Saves Kids) Campaign and the group's collective ASK Day efforts. The group would like to

focus on growing the ASK Campaign to a state-wide initiative in the coming year. Discussion centered around developing Georgia specific ASK Day Resources.

Collectively, the GCTE IP subcommittee will be working on planning this year's Trauma/IP Day at the Capital and Injury Prevention Summit to be held in conjunction with the Trauma Symposium in the Spring.
