Mr. Atkin said it was important to be cautious in developing a course as some may review the course components and deem the course not a right fit for them. At this time there is no one at the state level that is EMS education partner with technical school as each technical school is its own entity with its on graduate requirements. Mr. Terwilliger says we will continue talks about this at our next meeting. It may be a good partnership for us and a technical school. Mr. Terwilliger talked about rural health and trauma and STEMI and the limited access to care in rural areas. The trauma equipment grants equip 12counties that have a level one or two trauma centers. It is suggested we redirect those funds more towards rural trauma EMS care. He does not want to be unfair, but he does want to discuss redistribution. It was discussed that it will take significant funding to make a significant impact in rural health.
