02 MAY 2013 MINUTES APPROVAL:

Courtney Terwilliger asked the members for clarification on funding for the TCCC course. It was his understanding that the TCCC course would be funded with a portion of the funds previously allocated to the PHTLS course funding. All members agreed that this was their understanding as well.

Huey Atkins asked that the minutes reflect the fact that the items being funded did not match the priority rankings previously voted on by the group.

TELEMEDICINE DISCUSSION:

Paul Beamon from Spalding Regional EMS introduced Steve Brown from Spalding Regional IT Department to discuss their current telemedicine program.

EQUIPMENT GRANT – POTENTIAL WAIVERS:

The group discussed and moved on 3 requests for waivers for equipment grant expenditures. It was also noted that Lucas II devices are NOT contraindicated for traumatic arrest patients.

MOTION #4 EMS Subcommittee 2014-01-04:

There was discussion on tracking previous waivers granted for equipment grant purchases and whether to accept future identical waiver requests.

Brandon Fletcher will discuss a standard waiver requests form later in the meeting.

Equipment Grant Required Equipment Discussion:

Mr. Terwilliger discussed a potential list of required equipment EMS agencies must have on hand before they are allowed to utilize Equipment Grant funding to purchase additional trauma related equipment. His intention is to create a list of required equipment to take to the TMD group for discussion.

The list created by the group is as follows:

- 1. CAT tourniquets or equivalent
- 2. Hemostatic Dressings
- 3. Fluid Warmers
- 4. Blanket Warmers
- 5. I.O. Needles

Peki Prince expressed some concern with using the word "required" to describe the list of equipment.

AVLS Discussion:

Lee Oliver discussed the status of the AVLS program and its current funding.

Also discussed was the fact that GEMA had no plans at this point to fund additional AVLS phases of distribution past Phase 6.

NEW BUSINESS:

Mr. Terwilliger discussed the Child Seat Technician Course, it's funding, how to coordinate training classes and the selection of course attendees.

Brandon Fletcher discussed the status of the EVOC training program and future plans.

Mr. Terwilliger discussed the progress made on the state-wide triage system and the logistics of utilizing a state-wide triage tag including the options of creating/purchasing a new tag or utilizing an existing tag.

Mr. Terwilliger discussed the status of the Extrication Course. He also made a request for input on a possible individual who may be interested in taking a leading role in planning the course.

Mr. Fletcher discussed the creation of a more detailed and standardized Equipment Grant Purchase Waiver form and a desire for the form to contain more detail about the waiver request, including: the specific item, need, and examples of a past need for the item.
